These SMS Terms and Conditions (“Terms”) govern your participation in the SMS/text messaging program offered by Aladdin Rents (“Aladdin Rents,” “we,” “us,” or “our”). By opting in to receive SMS messages, you agree to these Terms.

1. Program Description

Aladdin Rents offers SMS communications to customers who provide consent. Messages may include, but are not limited to:

- Delivery and pickup notifications
- Account alerts and service updates

Message frequency will vary based on your interactions with Aladdin Rents.

2. Consent to Receive Messages

By providing your mobile phone number and opting in, you expressly consent to receive recurring SMS messages from Aladdin Rents at the number provided, including messages sent using an automatic telephone dialing system.

Consent may be obtained through, but is not limited to:

- Submitting forms via our website
- Providing your phone number in person, by phone, or electronically
- Verbal or written agreement to receive SMS messages

Consent is not a condition of purchase.

3. Message and Data Rates

Message and data rates may apply depending on your mobile carrier and service plan. Aladdin Rents is not responsible for any charges imposed by your wireless provider.

4. Opt-Out Instructions

You may opt out of receiving SMS messages at any time.

To stop receiving messages, reply: **STOP**

After you send STOP, you will receive a one-time confirmation message and will no longer receive SMS messages unless you opt in again.
